Authority allowing your stockbroker to access your Macquarie Cash Trust account

1 What is your account number?

through its authorised officers (your 'stockbroker') as notified to Macquarie from time to time to:
 withdraw funds from my/our Macquarie Cash Trust account;
 deposit credit balances on my trading account held with my stockbroker to my/our Macquarie Cash Trust account; and
 obtain information about my/our Macquarie Cash Trust account.

- 4 Terms and conditions**
1. You authorise your stockbroker to withdraw funds from your account through the direct debit system, by written request or any other method agreed in writing by Macquarie and your stockbroker.
 2. These withdrawals may be for any amount, which may include Bank Account Debits Tax on withdrawals, and may be made at varying intervals of time. Payment of moneys to your stockbroker by Macquarie is a good discharge of Macquarie.
 3. Macquarie may dishonour any drawing which is for more than the value of units available for withdrawal at the time the drawing is made. Macquarie has absolute discretion to determine the order of priority of moneys under this or other authority.
 4. You authorise your stockbroker to deposit credit balances directly into you Macquarie Cash Trust account.
 5. You can cancel this authority, but only after giving notice in writing to Macquarie.
 6. Macquarie can cancel this facility, but only after notifying you in writing.
 7. You indemnify Macquarie and your stockbroker against losses and liabilities incurred directly as a result of this authority. However, Macquarie remains liable for any loss or liability because of our neglect or default.
 8. You acknowledge that these terms and conditions are subject to the constitution relating to the relevant Macquarie Cash Trust.
